MONTE CHRISTO PAAIE HERSTELWERK PROJEK

Herstelwerk aan die paaie het onlangs aanvang geneem. Hierdie werk word verlang om die versakking van gedeeltes in die padnetwerk, hoofsaaklik waar dienstekruisings voorkom, te herstel. As deel van die herstelwerk sal enkele spoedhobbels, wat uit plaveistene opgemaak en te hoog is, verlaag word. Verbeterde toegang en addisionele parkering by die Landgoed se kantore word ook beplan.



Daar sal op padgedeeltes wat versak het gefokus word. Om verkeersvloei steeds te laat plaasvind, sal slegs een helfte van die versakking oor die pad herstel word en die ander helfte direk daarna. Waar versakkings direk voor die toegang na 'n woning moet plaasvind sal die eienaar geraadpleeg word rakende wanneer die werk verrig kan word met die minste ontwrigting. Daar is drie aansluitings aan die noordelike gedeelte van Blue Craneweg waar daar 'n redelike hoeveelheid herstelwerk moet plaasvind. Hierdie herstelwerk sal voorrang geniet.

MONTE CHRISTO PAAIE HERSTELWERK PROJEK

Die kontrakteur sal by twee areas vestig – eerstens by die park naby die noordepunt van Blue Craneweg en tweedens by 'n oop erf langs Guineafowlweg. Daar word beplan om die werk as volg aan te pak:

- (1) Aansluiting van Papegaaiduifstraat met Blue Craneweg
- (2) Aansluiting van Bosduifstraat met Blue Craneweg
- (3) Beskadigde gedeelte in Blue Craneweg tussen item (2) en item (4)
- (4) Aansluiting van Namakwaduifstraat en Blue Craneweg
- (5) Kingfisherweg en Rietduikerweg
- (6) Hierna sal paaieherstelwerk by verskeie verspreide areas en aanpassings aan spoedhobbels in die suidelike gedeelte van die Landgoed plaasvind. By die hoofhek van die Landgoed word daar ook herstelwerk benodig en kan verkeersvloei hier beïnvloed word. Toegang vanaf die hoofhek na Black Eagleweg kan via die sirkel in Blue Craneweg geskied

Daar word op alle Padgebruikers se veilige en bedagsame optrede tydens hierdie periode van ongerief staatgemaak.

FROM THE ESTATE MANAGER'S DESK SEPTEMBER 2024

Eienaars word vriendelik versoek om reëlings met Sekuriteit te tref indien jy nie by die huis gaan wees om jou pakkie wat per koerier afgelewer word, in ontvangs te neem nie. Residents are reminded of Rule 19.1 with regards to businesses run from home: No person may operate a business, profession or trade within the confines of the Estate without the written consent of the Management Committee which consent will not be unreasonably withheld due regard being had to a resident's right to earn a living and provided however, that the Management Committee shall be obliged to impose reasonable conditions on such resident. A monthly business levy may be imposed on such business owner as may be determined by the Management Committee from time to time.

Residents who are experiencing problems with barking dogs in the vicinity of their residences, are urged to download the "Bark Sense" app. This app only records the barking of the dogs. These recordings can then be used as evidence when laying a complaint.

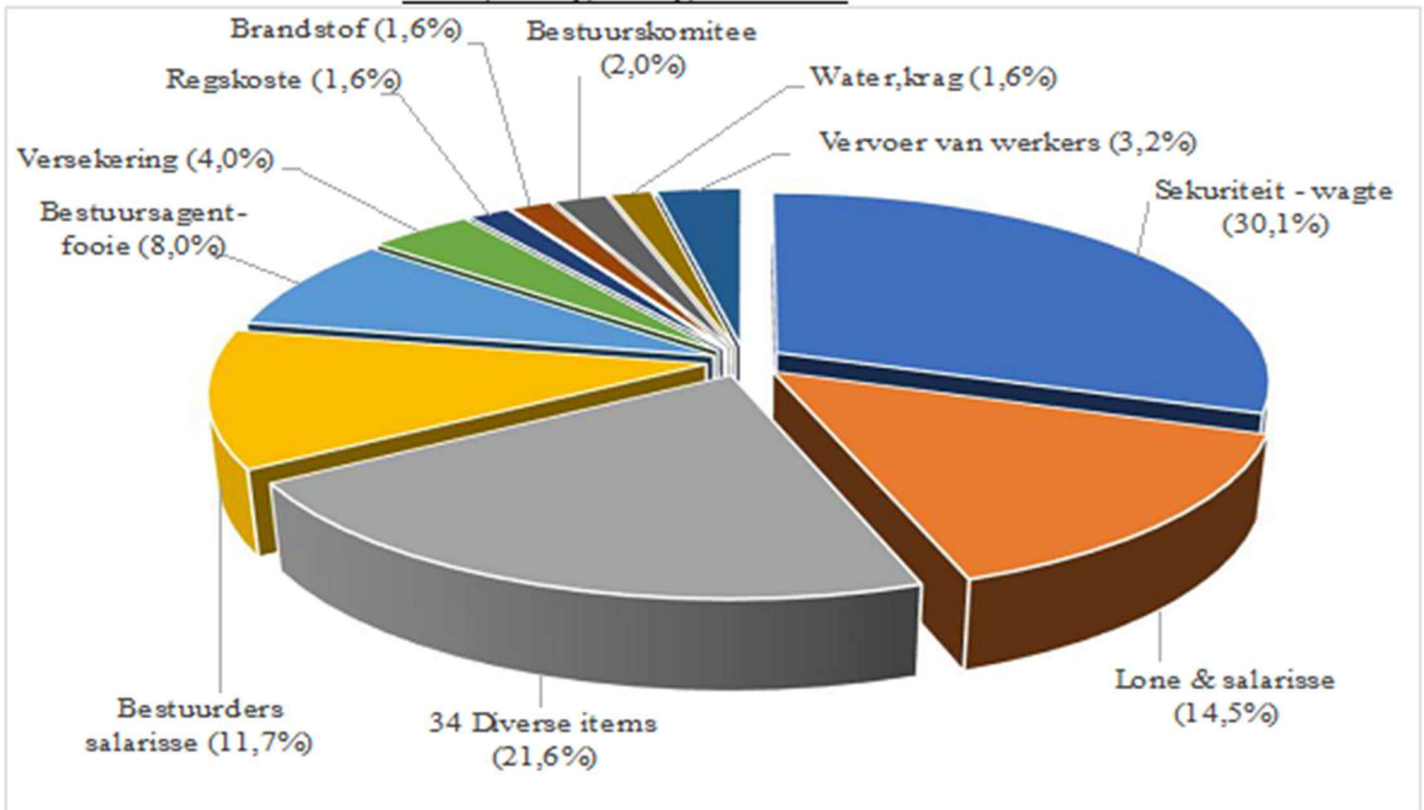

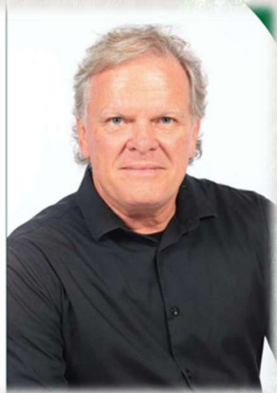

THE LAW AND ESTATE LIVING

A landmark decision was handed down in the **Constitutional Court** in the case of **Mount Edgecombe Country Club Estate v Singh and Others**. The essence of this decision and how it applies to Homeowners living in an Estate like Monte Christo, is the following:

- A) The roads within an Estate like Monte Christo will be regarded as private roads;
- B) Regulating the roads within Monte Christo will not be construed as usurping the functions reserved for the authorities under the National Road Traffic Act nor contravening the provisions of that Act;
- A) The current Estate rules are also not in conflict to the aforementioned Act;
- B) The Estate rules are contractually binding on the Residents and members and are enforceable against them; and
- C) There will also be no necessity for Monte Christo to seek any authority from the MEC or local Municipality to regulate conduct on the Estates roads.

WHAT IS THE EFFECT

Private Estates in South Africa are permitted to establish their own traffic rules and are thus entitled to issue their own traffic fines. Therefore, the Homeowners Association ("HOA") is allowed to charge fines to the levies of homeowners for speed and other transgressions

WHY IS THIS IMPORTANT

It is important to take notice of the above as the Management Committee of the HOA has decided to make use of an independent contractor named TMT to provide the traffic law enforcement equipment, back office systems and related services with no direct cost to the residents. The current Speed Camera of Monte Christo will be integrated into the system of TMT.

WHEN WILL THE SYSTEM BE OPERATIONAL

The system will be operational from **1 September 2024**.

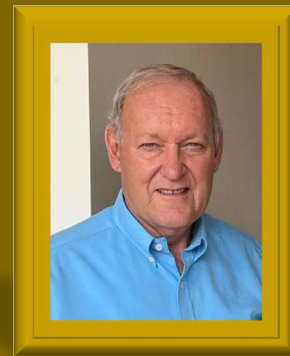

BEST LAMB CURRY EVER

750g lamb
2 cup plain yoghurt
2 tsp turmeric
2 tsp medium curry powder
2 tsp ground coriander
2 tsp ground cumin
¼ cup olive oil
2-3 cloves garlic- chopped
2 tsp fresh ginger- grated
1 tsp freshly ground black pepper
1 can chopped peeled tomatoes
2-3 Tbs chutney
juice of half a lemon
fresh coriander to garnish



METHOD:

The night/morning before:

Roughly chop the lamb, add it to a large mixing bowl and coat with the yoghurt, half the spices and half the chilli. Cover with Clingfilm and refrigerate.

Heat the olive oil in a pot and fry the garlic with the remaining spices and chilli, ginger and black pepper, allowing them to blend with the oil.

Add the lamb in batches so that the pot isn't too full. Stir and bring to a simmer.

Add the tomatoes, chutney and lemon juice and simmer gently for about 1 hour, the longer the better.

You will know you're close when the colour starts to change to a rich, Yellow color and the meat is tender.

Garnish with fresh coriander and serve with couscous, basmati rice or naan bread and minted tzatziki on the side.

500 ml (2 k) kookwater
180 ml (3/4 k) bruinsuiker
80 ml (1/3 k) heuning
100 g botter
375 ml (1½ k) bruismeel
1 eier
180 ml (3/4 k) melk



METHOD:

Verhit die kookwater, suiker, 60 ml (¼ k) van die heuning en die helfte (50 g) van die botter in 'n groot kastrol tot die suiker gesmelt is. Vryf intussen die res van die botter by die bruismeel in tot die meel soos broodkrummels lyk. Klits die eier, melk en die res van die heuning saam en voeg by die meelmengsel. Sny in tot 'n stywe beslag vorm. Verhit die sous tot dit liggies kook. Skep lepelsvol van die beslag in die kokende stroop. Bedek en prut vir 15-20 minute, sonder om die deksel een keer af te haal. Sit voor met vanieljroom of roomys.

Interesting facts about fynbos:

1. Fynbos flowers come in many different colours and shapes.
 - This can range from big, round blooms to long flowers with narrow petals. They can be any colour of the rainbow, from red, orange or purple to yellow.
2. Fynbos flowers are pollinated by insects and birds.
 - The brightly flowered fynbos is attractive to insects and birds which pollinate them by spreading pollen from one flower to another.
3. Fynbos flowers bloom at different times of the year.
 - There are always some fynbos flowers that are in bloom, and you can see different fynbos flowers during summer, spring and autumn.
4. Fynbos has many different uses.
 - This includes medicine, food, decoration, honey and tea.
5. Fynbos has a special relationship with fire.
 - Some fynbos are adapted to germinate after a fire. Their seeds are covered with a hard coat that only opens after it is exposed to heat, others have a mechanism to be spread by fire. This means that all fynbos does not die when there is a fire.
6. Fynbos is home to many different creatures.
 - This varies from reptiles, mammals, insects and birds. There are some species that are dependent on Fynbos, which includes the spurfowl, Cape mole-rat and Cape honeybee.
7. Fynbos is threatened.
 - Climate change, fire, habitat loss, invasive species are all threats to Fynbos. It is important to protect and restore Fynbos by managing fires and controlling invasive species.
8. Fynbos flowers are unique to South Africa.
